Section 1. The subject real estate located in Noblesville Township, Hamilton County, Indiana and is legally described in the attached Exhibit A (the "Real Estate").

Section 2. The use of Veterinary Animal Hospital, as defined in the UDO, shall be permitted for the Real Estate.

Section 3. Effective Date. This ordinance shall be in full force and effect upon its adoption and publication in accordance with the law. All prior ordinances or parts thereof in conflict therewith are repealed and deemed to conform to the provision of these amendments.
