To: Noblesville Board of Works Re: Request for Vehicle Purchasing

The Noblesville Police Department is seeking Board of Works approval for the purchase of vehicles, as part of our annual fleet replacement. These new vehicles will support our efforts in maintaining a fleet replacement program, whereby our older vehicles (7-10yrs old) are decommissioned, and new vehicles are purchased, up-fitted and placed into service.

The vehicles to be purchased at this time are two (2) Chevy Traverse SUVs. This purchase would be made according to the requirements specified in IC 5-22-8-3. We have received three separate quotes from dealerships who deal in these types of vehicles identified. Based upon the quotes received, it was determined that Kelley Chevrolet provided the lowest price quote for the two (2) Chevy Traverse SUVs needed. A summary of the quotes received are as follows:

Chevrolet Traverses (2 total) Kelley Chevrolet - \$62,300 Hare Chevrolet - \$65,960.50 Dan Young Chevrolet – declined


