AN INTERLOCAL AGREEMENT CONCERNING A ONE-TIME  
DISTRIBUTION OF PUBLIC HEALTH FUNDS

This Interlocal Agreement entered by and between Hamilton County, Indiana, acting by the Board of Commissioners of Hamilton County, ("the County"); the Hamilton County Council ("the Council:"); and Noblesville City Council, as the fiscal body of the City of Noblesville ("the Unit") on the dates set out herein.

WITNESS THAT:

WHEREAS, Hamilton County and the Hamilton County Health Department ("the Department") desire to locally promote and support statewide public health core service initiatives through its 2024 Health Frist Hamilton County (HFHC) grant administration program; and,

WHEREAS, the County and the Department desire to partner with the Unit to specifically support public health core service initiatives within the Unit through HFHC grant agreement # HFHC-55028515; and,

WHEREAS, the Unit's Fire/EMS Department maintains public outreach programs through its mobile integrated healthcare programs; and,

WHEREAS, the Department and the Unit have identified a need to provide access to preventative chronic disease prevention via diabetic testing & education as a core public health service gap; and,

WHEREAS, the Department and the Unit have identified a need to expand local trauma & injury prevention by establishing a program of certified car seat technicians who have the proper equipment allowing for multiple simultaneous inspections during car seat inspection clinics as a core public health service gap; and,

WHEREAS, Indiana Code § 36-1-7-12(b) permits one (1) Indiana governmental entity to make a purchase for another; and,

WHEREAS, Indiana Code § 36-1-7-12(d) permits two (2) governmental entities to procure equipment together; and,

WHEREAS, the County, the Department, and the Unit are dedicated to trying to maintain twenty-four (24) hour access to care and access to services that may decrease chronic diseases and trauma and injuries by public served.

IT IS THEREBY AGREED by Hamilton County and the Unit as follows:

1. The Unit shall purchase, install, and maintain, supplies and materials per the HFHC grant applications & agreement as identified by the Unit.

2. The County, through the Department Health First Hamilton County grant program, has appropriated funding from its Local Health Funding ("the Funding").

3. The County, through the Department, shall provide the Funding for the Units in the amount of Eight Thousand Two Hundred Ten Dollars (\$8,210.00).

4. The replacement of consumable supplies, and maintenance are solely the Unit's responsibility. As between the Unit and the County, any liability resulting from the use of the mobile integrated health care program would be borne by the Unit and not by the County. The County, nor the Department, shall be liable for any operations, maintenance, or use of healthcare or education equipment.

5. The Funding is contingent upon the Unit providing identified and measurable outcomes quarterly and an annual final report per the grant agreement to the Department.

a. The Unit shall provide the above-mentioned reports to the Department by the schedule due dates and final project completion date of December 31, 2024.

6. Funds are to be expended per the grant agreement budget as submitted by the Unit.


7. The undersigned executing this Interlocal Agreement represents that he or she has full power and authority to execute this Interlocal Agreement on behalf of the Unit and to fully bind the Unit to the terms and conditions herein.
