Noblesville Creates is requesting to close N. 8<sup>th</sup> Street between Conner and Logan Streets and activate all three pedestrian alleys for this year's annual HATCH Fest. This year's event will be held on Saturday, June 15<sup>th</sup> from 8 am to 7 pm, which is a combined event with the St. Michael's Strawberry Festival and SERVE Noblesville's F.U.N. Fest. There will be activities, performances and music in the alleys with themes celebrating Juneteenth, Technology and Heritage. Vendors will also have popup tents and tables on the Courthouse lawn and in the alleys. They are also requesting the 2 northmost parking spaces on the west side of N 9<sup>th</sup> Street between Logan Street and Conner Street.

The committee recommends the Board of Public Works approve this street closure, alley activation, and parking reservation request.






