CURRENT CONDITION

The 818 Logan Street building interior as well as exterior has been fully renovated within the past 5 years. Both are in excellent condition. The front façade of the building has been updated within the past 5 years, and a façade grant was used at that time. The plumbing and electrical fixtures are up-to-date. The roof was replaced in 2018 and is in excellent condition. Interior flooring and walls are also in excellent shape.


