**DATE:** March 12, 2024

The Noblesville Police Department is seeking Board of Works approval for the purchase and installation of new vehicle emergency equipment. This equipment will be used to upfit the police fleet vehicles purchased in 2024. Included is a special purchase resolution which explains the request in detail and the costs involved (Exhibit A).

As you will see within the purchase request, NPD is receiving a substantial savings from the vendor, American Eagle Equipment, with a 35% discount in equipment costs. This amounts to a total of \$99,528.15 in discounted savings. Additionally, American Eagle is reducing their labor costs to upfit the vehicles by \$400 per vehicle. American Eagle Equipment is a local business located in downtown Noblesville and they have been exceptional in their customer service and support provided to NPD.

When considering purchases of this type of equipment, NPD makes every effort to transfer existing emergency equipment from one fleet vehicle to the next to minimize spending. However, NPD typically maintains a fleet of vehicles up to 7-10 years depending on its service history, mileage and intended purpose. So, much of this equipment and emergency lighting becomes antiquated or faulty and extends beyond its effective lifespan. Also, due to routine manufacturer changes in interior and exterior body styles, much of the existing equipment is not able to transfer from one vehicle to the next 7-10 years later.

With that said, this request includes the necessary equipment and lighting to effectively equip our next round of fleet vehicles. We thank you for your consideration!

**Therefore, I recommend the Board of Public Works approve this purchase request with American Eagle Equipment.**



**APPROVAL OF SPECIAL PURCHASE FOR EMERGENCY LIGHTING AND  
INSTALLATION FOR NOBLESVILLE POLICE DEPARTMENT PATROL VEHICLES**

**WHEREAS**, in accordance with Ind. Code §5-22-10, et. seq., a purchasing agent may make a purchase without soliciting bids or proposals under various circumstances (“Special Purchase”);

**WHEREAS**, the City of Noblesville (“City”), by and through the Police Department desires to purchase emergency lighting upfitting packages for police vehicles, as more particularly described in Exhibit A, attached hereto and incorporated herein (“Upfitting Package”), from American Eagle Equipment (“American Eagle”);

**WHEREAS**, in accordance with Ind. Code § 5-22-10-5, a purchasing agent may make a special purchase when there exists a unique opportunity to obtain supplies or services at a substantial savings to the governmental body;

**WHEREAS**, Indiana Code §5-22-10-12 allows the City to make a Special Purchase when the market structure is based on price but the governmental body is able to receive a dollar or percentage discount of the established price;

**WHEREAS**, American Eagle Equipment has offered to provide the Upfitting Package to the City at a significant discount, reducing its labor costs by \$400 per vehicle and providing the City with a Thirty-Five percent (35%) discount on equipment purchases;

**WHEREAS**, American Eagle has offered to provide the discounted pricing stated herein to the City for subsequent purchases over a guaranteed period of time;

**WHEREAS**, utilizing American Eagle Equipment, the City is able to save a total of \$99,528.15 in discount savings;

**WHEREAS**, the Board now desires to approve the City’s special purchase of the Upfitting Package at a total cost of \$269,256.55, as more specifically described in Exhibit A, attached hereto and incorporated herein, and authorize the Police Department to enter into a contract with American Eagle for the guaranteed, reduced pricing of upfitting City vehicles over a certain period of time.

**NOW, THEREFORE, BE IT RESOLVED**, by the City of Noblesville Board of Public Works & Safety meeting in regular session as follows:

- Section 1. The Board hereby approves the City’s special purchase of the Upfitting Package with American Eagle, all as more particularly described in Exhibit A, attached hereto and incorporated herein.
- Section 2. The Board hereby authorizes the Police Department to execute the special purchase of the Upfitting Package; enter into a contract with American Eagle regarding the special purchase and subsequent City purchases at guaranteed, reduced pricing; and any and all documents necessary to effectuate its intent.

Section 3. This Resolution shall be of full force and effect from and upon its adoption and in accordance with Indiana law.

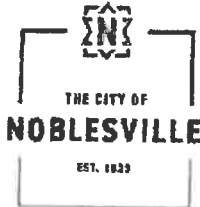
