

RE: Secondary Plat Approvals

This request is for two separate secondary plats which are both located in the Noble West Planned Development located north of E. 146th Street and east of Hazel Dell Road. It is a mixed use area including single-family residential, townhomes, apartments, school, public park, office uses, and commercial uses.

Replat of Block A of Noble West Shoppes

This particular property is the site of the Kroger Store and the adjacent area to the south. The application includes a replat of the area to establish two lots (1) for the Kroger site/expansion and (2) for a future inline tenant building. The lots will be known as 11 and 12.

Replat of Block C of Noble West Shoppes

This property is located adjacent to E. 146th Street just east of Hazel View Road. It is currently labeled as Block C and they are creating one lot (Lot 10) from the current acreage for the construction of a Kroger Fuel Center with the remaining 1.27 acres still noted as Block C.



