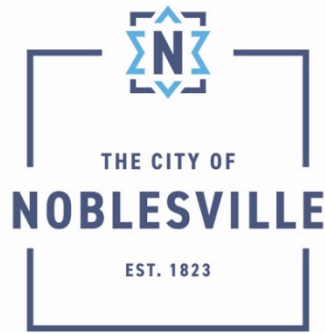

**SUBJECT:** Road Closure Request for Logan Street, Nixon Street, & John Street  
Village at Federal Hill

**DATE:** May 28, 2024

The Village at Federal Hill team is requesting roadway closures in three locations where temporary patches were placed over the winter. These closures are summarized below.

- Nixon Street (north of Logan Street) & John Street (south of Logan Street)
  - On or after June 3<sup>rd</sup>, 2024
  - Up to three (3) consecutive daytime closures from 8am to 4pm
  - Roadway must be open and plated outside of above stated working hours
- Logan Street (east of Nixon Street)
  - On or after June 3<sup>rd</sup>, 2024
  - Up to three (3) consecutive night closures from 8pm to 6am
  - Roadway must be open and plated outside of above stated working hours

All work must be completed prior to the SR32 Reconstruction project shifting from Phase 2 (9<sup>th</sup> & 10<sup>th</sup> Street closures) to Phase 3 (8<sup>th</sup> Street closure), which is anticipated to occur on or after June 7<sup>th</sup>, 2024.

Old Town Construction will be responsible for notifying residents and businesses in the general area of construction.

Any closure outside of the allowable timeframes listed in this memo would be a violation of city ordinances and would be subject to any and all penalties, fines, and other enforcement mechanisms, including liquidated damages of \$1,000 per half hour of closure that extends beyond the allowable closure times listed in this memo.

**I recommend the Board of Public Works and Safety approve these closures subject to the conditions listed in this memorandum.**





### **Request of Road Closure**

- Old Town Construction requests the following Road Closure's the week of June 3<sup>rd</sup> through June 7<sup>th</sup>. We anticipate these roads to be closed for one day, requesting the week for whether consideration.
  - Close John Street and Nixon Street starting at 8 am on June 3<sup>rd</sup> for street crossing patch and repair. We anticipate these roads be opened back up by 5 pm on June 3<sup>rd</sup>.
  - Close Logan Street at 6 pm on June 3<sup>rd</sup> for street crossing patch and repair. We anticipate this road would be opened back by 6 am June 4<sup>th</sup>.
