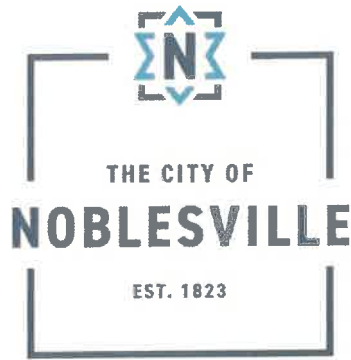

DATE: June 25, 2024

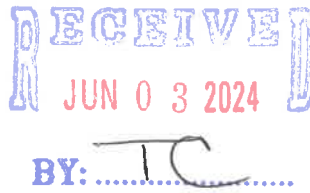

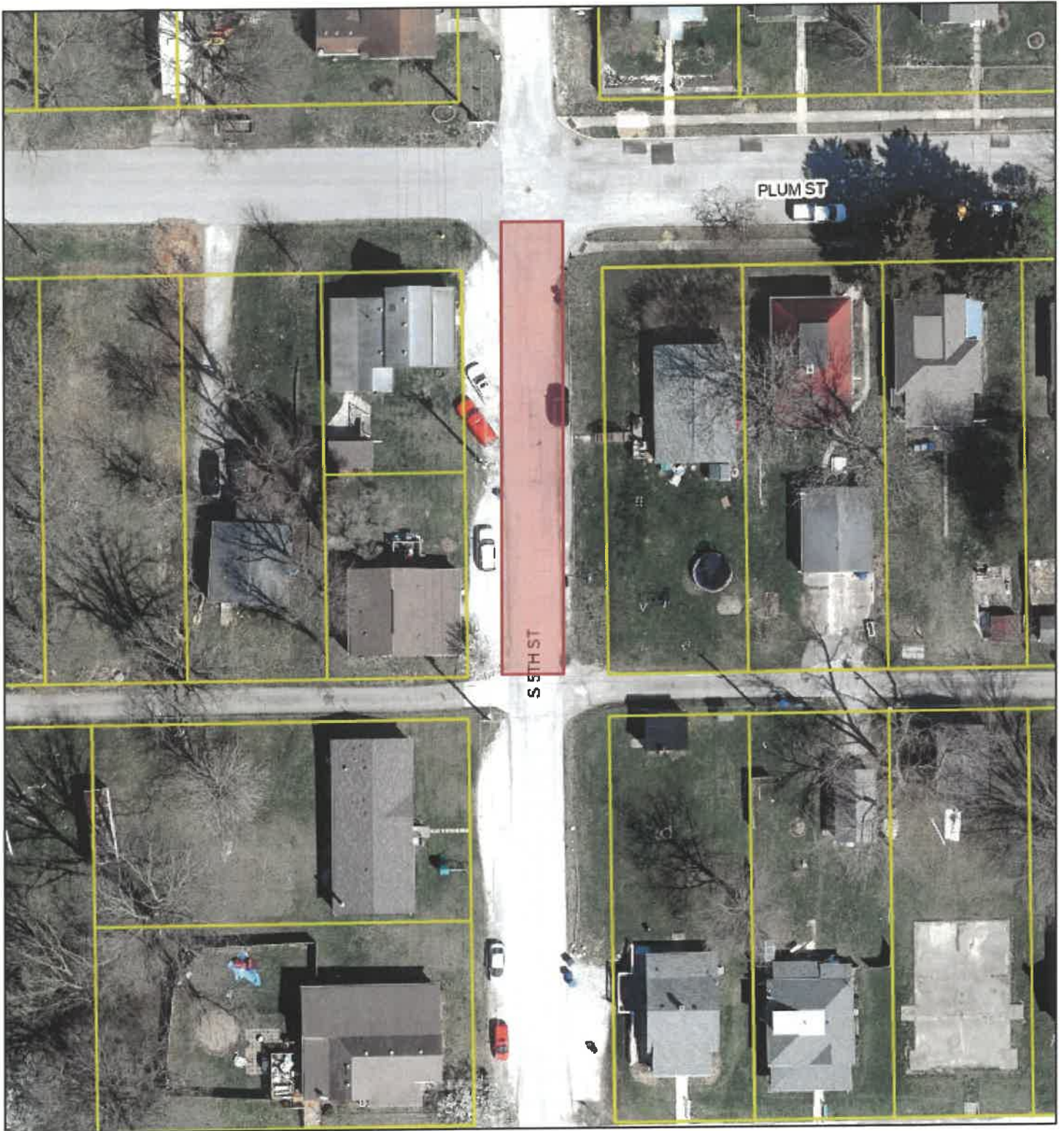
