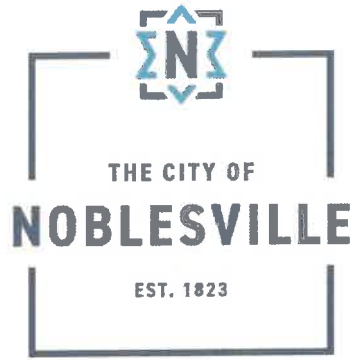

Attached you will find a request from Chuck Townsend to close Granduer Court, in the Union Crossing subdivision, for a block party on July 12th from 6:00PM to 11:00PM.
