Attached is the Residential Façade Improvement Grant Application submitted by Mary Goins for the property at 548 South Street.

The total façade project cost is estimated at \$9,425 with a grant of \$7,068.75. This home is in the Plum Prairie Historic District which allows for a 75% grant match up to \$7,500. This grant is for the rehabilitation of a detached garage including new siding, windows, entry and overhead door and painting as well as removal and replacement of any rotted wood.

Pending your approval, the property owners will be contacted and work can begin. All of the façade improvements must be started within 60 days and be completed within 12 months of approval.

After completion all façade improvements must be inspected by the Program Administrator and certified building inspectors to verify work has been completed according to the Façade Improvement Agreement. "After" photos and paid invoices itemizing all eligible costs will be submitted to the Mayor's Office for verification. After all work has been completed and verified, funds will be disbursed.







Some siding is missing, some has been replaced with fence boards, and all the exterior wood has been weathered past the point of repainting. Some wall studs are missing or rotted. The roof is fairly new with all new decking and shingles.

The scope of the project includes demolition, installation, painting, and removal of debris. All of the exterior siding and trim will be removed and the rotted or missing studs will be replaced or repaired. New exterior siding and trim will be installed, including double pull doors matching the overall finish of the structure. One coat of primer and at least two coats of paint will be installed on all exposed wood. All debris will be removed from the site and the grounds swept with magnets to ensure a safe lawn.

Pieces of siding are missing, some has been replaced with fence boards, and all the exterior wood has been weathered past the point of repainting. Some wall studs are missing or rotted. The roof is fairly new with all new decking and shingles.

The scope of the project includes demolition, installation, painting, and removal of debris. All of the exterior siding and trim will be removed and the rotted or missing studs will be replaced. New exterior siding and trim will be installed, including double pull doors matching the overall finish of the structure. One coat of primer and at least two coats of paint will be installed on all exposed wood. All debris will be removed from the site and hauled to the trash dump. and the grounds swept with magnets to ensure a safe lawn.
