**RESOLUTION TO OPT IN TO PARTICIPATION OF THE KROGER OPIOID SETTLEMENT**

**WHEREAS**, the City of Noblesville, Indiana (hereinafter “City”) has been actively engaged in pursuing damages caused by the manufacture, sale, and distribution of opioids through outside counsel in multidistrict litigation;

**WHEREAS**, outside counsel for the City recommends the City’s participation in the Kroger Settlement; and

**WHEREAS**, the City, after due consideration, has determined that it is in the best interest of its citizens to participate in the Kroger opioid settlement.

**NOW, THEREFORE, BE IT RESOLVED**, by the Common Council of the City of Noblesville, Hamilton County, Indiana as follows:

1. The City of Noblesville, Indiana, having considered participation pursuant to Ind. Code § 4-6-15-2 in the Kroger opioid settlement now confirms its participation in the opioid settlement.
2. Settlement proceeds shall be used consistent with applicable law and the court-approved terms of the opioid settlement.
3. The Mayor of Noblesville is hereby authorized to execute and submit the individual entity Settlement Participation Agreements and all necessary exhibits.
