RESOLUTION TO OPT IN TO PARTICIPATION OF THE KROGER OPIOID SETTLEMENT

WHEREAS, the City of Noblesville, Indiana (hereinafter "City") has been actively engaged in pursuing damages caused by the manufacture, sale, and distribution of opioids through outside counsel in multidistrict litigation;

WHEREAS, outside counsel for the City recommends the City's participation in the Kroger Settlement; and

WHEREAS, the City, after due consideration, has determined that it is in the best interest of its citizens to participate in the Kroger opioid settlement.

NOW, THEREFORE, BE IT RESOLVED, by the Common Council of the City of Noblesville, Hamilton County, Indiana as follows:

- The City of Noblesville, Indiana, having considered participation pursuant to Ind. Code § 4-6-15-2 in the Kroger opioid settlement now confirms its participation in the opioid settlement.
- 2. Settlement proceeds shall be used consistent with applicable law and the courtapproved terms of the opioid settlement.
- 3. The Mayor of Noblesville is hereby authorized to execute and submit the individual entity Settlement Participation Agreements and all necessary exhibits.
