DECLARATION OF PROPERTY OF THE NOBLESVILLE UTILITIES DEPARTMENT AS SURPLUS BY THE NOBLESVILLE BOARD OF PUBLIC WORKS & SAFETY

WHEREAS, Indiana Code Title 5 provides that the Board of Public Works and Safety ("Board") of the City of Noblesville, Indiana ("City") may declare certain personal property of the City as surplus and dispose of such surplus property upon a declaration and for reasonable value; and

WHEREAS, it has come to the attention of the Board that certain property owned by the Noblesville Utilities Department is now surplus and that the same should be disposed; and

WHEREAS, the Noblesville Utilities Department owns and has utilized one (1) 2003 Sterling L7500 Jetter Truck ("Jetter Truck") and one (1) 2006 Ford E450 Camera Truck ("Camera Truck") which are no longer needed or are unfit for the purpose for which they were intended; and

WHEREAS, pursuant to Indiana Code § 5-22-22-4.5, the Board may dispose of the surplus Jetter Truck and Camera Truck by internet auction; and

WHEREAS, pursuant to Indiana Code § 5-22-22-5, if the surplus Jetter Truck and Camera Truck are not sold through an Internet auction, the Board may sell the property by receiving sealed bids; and

WHEREAS, the Board desires to set forth the terms and conditions by which the City may dispose of the Jetter Truck and Camera Truck, by sale.

NOW, THEREFORE, BE IT RESOLVED by the Noblesville Board of Public Works & Safety of the City of Noblesville, meeting in regular session, hereby declares as follows:

SECTION 1. The above recitals are incorporated herein by this reference as though fully set forth herein.

SECTION 2 The following Noblesville Utilities Department assets are hereby declared surplus personal property within the meaning of Indiana Code § 5-22-22 et seq:

SECTION 3. It is further resolved that the Director of the Noblesville Utilities Department or his designee shall be authorized to dispose of said surplus property by following the procedures set forth in Indiana Code § 5-22-22-4.5 for an internet auction and shall also follow the notice procedures set forth in Indiana Code § 5-22-22-11.

SECTION 4 If the City is unable to dispose of the Jetter Truck and Camera Truck by internet auction, it is further resolved that the Jetter Truck and Camera Truck may be sold by sealed bid and the Director of the Noblesville Utilities Department or his designee shall be authorized to provide advertisement of the sale in accordance with Indiana Code § 5-3-1.

SECTION 5. This declaration is effective upon its adoption.
