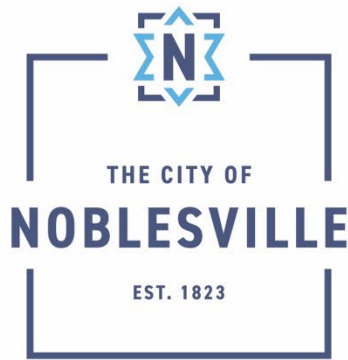

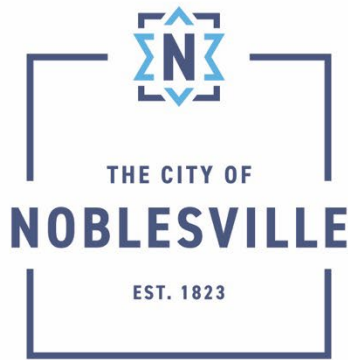

SUBJECT: Board to Consider Solicitation of Quotes for the Federal Hill Commons Monument Sign

DATE: November 12, 2024

The Parks Department is requesting to solicit quotes to replace and update the monument sign at Federal Hill Commons. Planned as part of the departments post-construction agenda, following the completion of Federal Hill Village. The sign is planned to be V-shaped and will include electronic message boards, visible to traffic on Logan Street and SR 19.

The Parks Department recommends the Board of Public Works approve the request to solicit quotes for the Federal Hill Commons Monument Sign.



REQUEST FOR QUOTES

Federal Hill Commons Monument Sign

The City of Noblesville is soliciting quotes for the installation of a new monument sign at Federal Hill Commons.

DESCRIPTION OF WORK: The monument sign is to be located on the east portion of the property and must include two display screens that are compatible with the City's existing software that runs on Watchfire Electronic Messaging Center panels. The sign must adhere to the following specifications:

- Aluminum, V-shaped sign
- 4' x 14' electronic message displays (one on each side), visible to Logan St and SR 19
- Installation and foundation, including bringing electric to sign

The design must be of a design acceptable to the City of Noblesville. The City requests that the sign be quoted and installed by the end of December of 2024.

If you are unable to meet the City's timeline for this project or otherwise unable to quote, please respond to the email soliciting this quote in writing by the date listed below.

If you are interested in participating, your quote must be delivered to the City of Noblesville in a sealed envelope at **16 S Tenth St, Noblesville, IN 46060 by November 12, 2024 by 4:00 PM EST**. Quotes will be opened at the Noblesville Board of Works Meeting on November 12, 2024 at 9:00 am and the City may award the quote at that or any subsequent meeting. Include with your quote the proposed design for the sign, the time for installation, and the cost of install.
