Agenda Item 5: Merit Commission to consider adoption of revised Merit Law 36-8-3.5-12 section (a) sub-section (3) regarding maximum age of eligibility (Hamilton County Professional Firefighters Association Local 4416)

Chief Dixon said that the paperwork that was distributed to Merit Commission members showed the proposed changes to this item. The verbiage in the paperwork that Chief Dixon referred to read as follows:

"SECTION 2. IC 36-8-3.5-12, AS AMENDED BY P.L.103-2021, SECTION 2, IS AMENDED TO READ AS FOLLOWS [EFFECTIVEJULY 1, 2023]: Sec. 12. (a) Subject to IC 36-8-4.7, to be appointed to the department, an applicant must be:

- (1) a citizen of the United States;
- (2) a high school graduate or equivalent; and
- (3) at least

(A) twenty-one (21) years of age, but under thirty-six (36)years of age, if the person is an applicant to the fire department; or

(B) twenty-one (21) years of age, but under forty (40) years of age. if the person is an applicant to the police department.

However, the age requirements do not apply to a person who has been previously employed as a member of the department."

John Huseman said this is a housekeeping item to revise our Merit Law so that it reflects a change in state law which already went into effect on May 1, 2023.

Commissioner Glodowski made a motion to approve the adoption of revised Merit Law 36-8-3.5-12 section (a) sub-section (3) regarding maximum age of eligibility, as presented by Chief Dixon and Mr. Huseman.
