Old Business:

Tree Planting Grant Program:

Planning for this continues. The draft documents have been prepared & reviewed by the tree board. The next steps are:

- 1. The city to review the program documents.
- 2. Developing the metrics (point system) to prioritize projects for awarding grants. (this is a topic for next committee meeting)

UDO Revision and Tree Preservation/iTree:

Previously, there was a discussion about what items the tree board could contribute (if a conversation with city agencies occurs about potential Unified Development Ordinance (UDO) update). The goal is to come up with ideas that could solve current problems regarding tree planting & maintenance as well as increase efficiency of city operations. A list of items will be compiled by this board and presented to city staff (in a lunchtime, collaborative meeting) for further discussion.

This meeting was put on hold until it was a more favorable time for all parties. A more favorable meeting date could be this fall (potentially early November) or winter (potentially January 2024). Ashley to email Matt Light to coordinate & schedule.

2024 Budget Discussion:

A letter of support regarding the urban forestry efforts was sent to the Mayor's office for consideration during the 2024 budget discussions/allocations. The budget discussions are ongoing. The 2024 city budget is anticipated to be finalized by October.

 - The Education & Outreach committee met last month and prepared draft documents for the Tree Planting Grant program general requirements. Work will continue at our next committee meeting.

Noblesville Tree Board Meeting: August 7, 2023

- 1. Engineering Project: Chapel Woods: 6 stumps remain and some pruning. This should be completed by the end of next week.
- Engineering Project: Old Town (South of Cherry St, North of Pleasant Street, between 10th Street and 19th Streets) 12 trees still to be removed w/stumps and LOTS OF PRUNING. Will likely not move further until 2024. No brick sidewalks involved, just concrete. Possible panels along 10th with stamped brick pattern (if so, more trees will be involved, but trying to keep to a minimum).
- I have met with HOA leadership regarding street trees and ordinance requirements: Merion of Noblesville and Marilyn Ridge of Noblesville. Also discussed with Wellington NE HOA about street tree plantings in front of common area parks. They must work out a plan to refill water bags before any new trees will be installed.
- 4. The Monthly email info sheet to HOA and Property Management group representatives with information regarding street trees: August-Information on tree leaf defoliation and continued problem with volcano mulch causing dieback.
- 5. Here is the documentation from the City which requires residents to maintain the City ROW in front of their property. I have had a handful of folks pushing back against this. Here is that information located in the Noblesville City Code, Title IX, General Regulations, Chapter 93, Section 5:

§ 93.05 WEEDS, GRASS AND DEBRIS.

- (A) Any owner of real estate located within the city or the tenant residing therein shall be required to cut high weeds and grass, and remove debris and rubbish from said real estate within five days after receiving written notice of such requirement from the planning department. Property owners shall also be responsible to cut high weeds and grass, and remove debris and rubbish from the area between the streets and sidewalks adjacent to the real estate.
 - (D) Grass, excluding ornamental grass, shall not exceed six inches in height.
