## *Release of Liability Waiver*

---

Your group has agreed to adopt a designated stretch of road located in the City of Noblesville and identified by the Noblesville Street Department. Your group will be responsible for cleaning up litter at this stretch of road at least two times a year for one season, beginning April 1<sup>st</sup> and ending November 1<sup>st</sup>.
