AN ORDINANCE TO AMEND THE ZONING ORDINANCE, A PART OF THE MASTER PLAN OF THE CITY OF NOBLESVILLE, HAMILTON COUNTY, INDIANA

An Ordinance to Amend the Unified Development Ordinance of the City of Noblesville, Hamilton County, Indiana, enacted by the City of Noblesville under authority of Chapter 174 of the Acts of the Indiana General Assembly 1947, as amended.

WHEREAS, the Plan Commission of the City of Noblesville (the "Commission") has conducted a public hearing as required by law in regard to the application for a change of zone district designation filed by Brenwick Development Company, Inc. for the real estate containing approximately 4.04 acres, legally described on Exhibit "A" attached hereto, and located in Noblesville Township, Noblesville, Indiana (the "Real Estate").

WHEREAS, the Commission has sent to the Common Council its recommendation adopted on the 19th day of _______, 2003.

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Noblesville, Hamilton County, Indiana, meeting in regular session, that the Unified Development Ordinance of the City of Noblesville, Indiana ("Ordinance") and the Zone Map of the Ordinance are hereby amended as follows:

SECTION 1. The Real Estate is hereby zoned to the R-1 zoning district classification of said Ordinance.

Land Description

A part of the Northwest Quarter of Section 15, Township 18 North, Range 4 East, in Hamilton County, Indiana, being described as follows:

Beginning at the northwest corner of said Quarter Section; thence North 89 degrees 49 minutes 39 seconds East along the north line thereof a distance of 457.08 feet; thence South 00 degrees 00 minutes 48 seconds East parallel with the west line of said Quarter a distance of 385.47 feet; thence South 89 degrees 49 minutes 39 seconds West parallel with said north line a distance of 457.08 feet to the west line of said Quarter; thence North 00 degrees 00 minutes 48 seconds West along said west line a distance of 385.47 feet to the Point of Beginning, containing 4.04 acres, more or less.
