
What is the Plan Commission?

The Noblesville Plan Commission meets on the third Monday of every month at Noblesville City Hall (Council Chambers), 16 South 10th Street, Noblesville, IN 46060. They help to shape the city's growth and development and help the Common Council develop and update City Ordinances, the Comprehensive Plan, the Thoroughfare Plan and other long-range planning functions. The Plan Commission consists of 11 voting members and conducts public hearings for land use zoning and land subdivision activities.

FAQs

Q: How long does each hearing last?

A: No longer than 20 minutes

Q: How do I make a comment in the Plan Commission Meeting?

A: Fill out a "Request to Speak" Form and present it to the Recording Secretary. The form can be found on the table at the Council Chambers entrance.

Q: What is the proper way to speak in front of the Plan Commission?

A: When the President calls your name, come forward to the podium, speak into the microphone, and clearly state your name and address.

Closing of the Public Hearing

The President of the Commission may increase the length of the hearing if it is requested by the applicant or agent representing the applicant. If the President decides that the Commission has adequately heard from all parties, then he/she closes the public hearing. At this point all comments, questions, and concerns by the audience and applicant should have already been addressed. A motion is made, and seconded, by the Commission for a continuance, dismissal, or vote on final recommendations or decisions in accordance to Article VI of the Rules of Procedure for the Noblesville Plan Commission. A record of the proceedings and vote will be kept by the Recording Secretary and filed in the Planning Department Office at 16 South 10th Street, Suite 150, Noblesville, Indiana 46060.

When Addressing the Plan Commission...

- When called upon, come forward to the podium.
- Speak into the microphone.
- State your name and address clearly for the record.
- Provide written material to the Secretary as well as the Commission.
- Place any displays, charts, or graphs on the stands provided so your information is visible to the Commission and the audience.
- Address all comments to the President and speak only when recognized.
- Do not make comments to the audience.
