## AN ORDINANCE TO AMEND THE ZONING ORDINANCE, A PART OF THE MASTER PLAN OF THE CITY OF NOBLESVILLE, INDIANA,

WHEREAS, the Plan Commission of the City of Noblesville (the "Plan Commission") has conducted a public hearing as required by law on Application #05J-14-1446 for a change of zoning from "SR" (Suburban Residential) setting to the 'R1' Low to Moderate Single-Family Residential of the Unified Development Ordinance of the City of Noblesville, Hamilton County, Indiana (the "Ordinance") for the real estate which is described on Exhibit A attached hereto (the "Real Estate") depicted on Exhibit B attached hereto; and


